RULES OF THE GWENT ART CONTEST

§ 1

GENERAL PROVISIONS

- 1. This document (further: "Rules") describes the terms and conditions of GWENT Art Contest (further: "Contest").
- 2. Within the Contest we invite you (further: "Contestant") to present us your artwork showing a character from the Witcher universe that has not yet been portrayed in GWENT: The Witcher Card Game ("Artwork") and submit the artwork at https://www.playgwent.com/art-contest. The prizes will go to the Contestants whose Artworks are the most creative, original and of the highest quality.
- 3. The Contest is open for participants all around the world.
- 4. The Contest is organised by us, the company CD PROJEKT S.A., with its registered office in Warsaw, Poland, ul. Jagiellońska 74, 03-301 Warszawa, registered by the District Court for Warsaw in Warsaw, 13th Commercial Department of the Polish Court Register, under Polish Court Register number KRS 0000006865, tax identification number NIP 7342867148, statistical number REGON 492707333; share capital of PLN 96,120,000.00, paid up in full (further: "we" or the "Organiser").

§ 2

WHO CAN PARTICIPATE?

- You can participate in the Contest if:
 - a. you are at least 18 years on the day of entering the Contest and you have full legal capacity, i.e. you
 can independently enter into legal transactions, including binding contracts, in accordance with your
 local law, or
 - b. you are between 13 and 18 years on the day of entering the Contest and your parent or guardian reviewed these Rules and approved your participation in the Contest.
- You cannot participate in the Contest if you are an employee of the Organiser or of its affiliates, subsidiaries, manufacturers, sales representatives or advertising agencies; or a member of such employee's immediate family.

§ 3

WHEN THE CONTEST TAKES PLACE?

- The Contest begins on 22 February 2018 and will end on 6 April 2018 14:00 CEST ("Contest Period"). You
 must submit your Artwork by the end of the Contest Period. Any Artworks submitted outside the Contest Period
 will not be included in the Contest.
- All qualifying Artworks will be published at https://www.playgwent.com/art-contest within 10 days after the end of Contest Period allowing Gwent community to vote for their favourite Artwork by giving likes ("Community Vote"). The Community Vote will begin as soon as the Artworks are published and will end on 27 April 2018 14:00 CEST.
- 3. The winners will be announced on 30 April 2018.

§ 4 HOW TO PARTICIPATE?

- 1. In order to participate, make a creative Artwork showing a character from Witcher universe that has not been portrayed on any card available in GWENT: The Witcher Card Game until the beginning of the Contest Period.
- 2. The submitted Artwork must be 2D digital picture in JPG or PNG format in the size of 3500x5000 pixels.
- 3. Submit your Artwork at https://www.playgwent.com/art-contest.
- 4. You may provide only one submission containing only one piece of Artwork. The submissions containing multiple Artworks or subsequent submissions of the same Participant will not qualify.
- 5. Submissions provided in any other way do not qualify.
- 6. Artwork must be appropriate to show to minors and should comply with PEGI 12 requirements.
- 7. The Organiser reserves the right to reject a Contestant's submission if it violates the provisions of applicable law, Contest rules or if the Artwork may be considered racist, xenophobic, sexist, defamatory or otherwise offensive, illegal or non-compliant with PEGI 12 requirements.

§ 5

HOW WILL THE WINNERS BE CHOSEN?

- 1. Winning submissions will be selected by the Contest Committee consisting of the GWENT Art Director, GWENT Art Producer, and GWENT Community Specialist.
- 2. The Contest Committee will choose the winning Artworks based on creativity, originality and quality of Artwork.
- 3. The Contest Committee's decisions are final.
- 4. The Contest Committee will choose three Artworks and award them respectively First, Second and Third Prize.
- 5. Artworks who earned the most votes during Community Vote will be awarded respectively First, Second and Third Community Favourite Prize.
- 6. Prizes and Community Favourite Prizes cannot be cumulated. Artworks who earned First, Second and Third Prize will not be eligible to receive any of the Community Favourite Prizes even if they would qualify for Community Favourite Prize by vote's count. In such case the Community Favourite Prize will be awarded to the Artwork with the next number of votes that has not received any of the Prizes.
- 7. The Organiser reserves the right to award other special prizes at its sole discretion.
- 8. The Organiser reserves the right to contact chosen Participants and invite them to possible cooperation or participation in recruitment process.

§ 6

- 3. The prizes will be sent by mail to the addresses provided by the winners. The Organiser will cover the prize shipment cost. The Meteorite Powder will be awarded to the user account indicated by the Contestant.
- 4. If necessary by applicable law, the Prizes will be supplemented with cash prize equal to the tax due on the prize. The Organiser will deduct the cash prize and will pay the tax due under Polish law.
- 5. All the winners will be informed about the Contest results by a public post on the official Gwent social media channels. The Organiser will also contact winners using the e-mail address used by the Participants to provide the Artworks. Each winner will have seven (7) days to confirm by e-mail whether he or she accepts the prize and to provide a postal address to which a prize will be sent and/or account the Meteorite Powder will be awarded. If a Contestant fails to contact us within that deadline or refuses to accept the prize, we retain the right to award such prize to another Contestant or to refrain from awarding this particular prize.

§ 7

CONTESTANT'S OBLIGATIONS AND DECLARATIONS

- 1. By sending the submission in accordance with § 4 above, you (as a Contestant) confirm that you fulfil the requirements set out in the Rules.
- By sending the submission, you agree that if you win the Contest, the Organiser may use your e-mail username or name provided in application e-mail in announcements of the Contest results or in any other promotional materials applicable to the Contest.

§ 8

COPYRIGHT

- 1. By sending your submission, you (the Contestant) grant us (the Organiser) a non-exclusive, worldwide, non-transferable, royalty-free licence to use the Artwork for the purpose of the Contest, including providing the Artwork to the Contest Committee members and publishing it at Contest's webpage, our websites and/or social media. This licence covers in particular the following forms of exploitation:
 - a. producing copies of the Artwork using all techniques;
 - b. distribution and dissemination of the Artwork in all channels;
 - c. making the Artwork available in a manner allowing any person to access the Artwork in a place and at a time selected by them.
- 2. Licence referred to in § 8 point 1 is granted for an indefinite time.

INDEMNITY

The Organiser will not cover any potential costs incurred by the Contestant in connection with the Contest, including entering the Contest, preparing and submitting the Artwork and receiving the prize, subject to § 6 above.

§ 11 FINAL PROVISIONS

- The Rules will be governed and construed in accordance with the Polish law.
